Family Resource Center Opens at College Heights

Very child is a star! That's the title of the new art installation in the reception area at the College Heights Early Childhood Learning Center. Designed and created by Decatur artist/architect Joseph Dreher, the three-dimensional artwork was commissioned as part of a grand project undertaken by DEF to transform the building into a teaching tool for both parents and children.

At the request of Superintendent Dr. Phyllis Edwards, the Foundation board raised funds to equip the school's reception area and to create a Family Resource Center that would provide instructional materials and equipment to encourage family learning. Since active involvement in the Early Childhood Center is one of DEF's chief strategic goals, the project was a natural fit.

The goal of the project was to create attractive spaces that promote good parenting skills, family literacy, and family engagement around learning. Numerous professionals assisted us in planning and designing the space, selecting colors and fabrics, ordering furniture, and choosing appropriate instructional materials. The design is based on the theme of learning and growing, and incorporates basic early childhood concepts: letters, numbers, colors, and shapes.

The Family Resource Center includes



child-friendly computers; educational software programs; books, magazines, and DVDs on various parenting topics; children's books; instructional DVDs; literacy kits for check out; mathematics kits for check out; and instructional puzzles and toys. Also available to parents are art supplies, a die cutter, and a laminator for creating teaching tools that will help them reinforce their child's learning at home.





We have made tremendous strides toward ensuring that our work is significant and will have a lasting impact.



Patrick Family Foundation Scholarship Moves to DEF

he Patrick Family Foundation was established in 1988 by Decatur residents Joseph E. and Geraldine A. Patrick. Decatur High School alumnae Joe (Pat) Patrick (DHS 1963), Hilda Buchanan Patrick (DHS 1962), and Dorothea Patrick Smith (DHS 1968) established the scholarship fund in 2002 with the Community Foundation for Greater Atlanta (CFGA). The family moved the fund to the Decatur Education Foundation in 2006 with the full blessing of the CFGA.

The Patrick Scholarship is the largest single scholarship currently available exclusively to Decatur High School students. Recipients of the award must apply and are selected based on demonstrated initiative, potential for success in higher education, and financial need. The \$5,000 award is renewable for four years of postsecondary study.

Community Foundation President Alicia Philipp said, "We connect donor passion to community need by educating and engaging those donors with the issues that are at the core of their communities. The Patrick scholarship awards money to a Decatur High School graduate, so . . . it makes incredible sense for CFGA to transfer that fund to the Decatur Education Foundation to ensure an even closer connection to the Decatur students."


